(2) Nondisclosable confidential business information is privileged information, classified information, or specific information (e.g., trade secrets) of a type for which there is a clear and compelling need to withhold from disclosure. The rules and definitions. Privilege is a fundamental legal right. It allows individuals and corporate entities to resist disclosure of confidential and sensitive material. There are strict rules on when privilege applies under English law: not all communications with lawyers and other advisers will be protected.

Privilege under English law: The rules and definitions ...

Privileged and confidential communication is the interaction between two parties having a legally protected, private relationship. Law cannot force such parties to disclose the content of communication made between them. An individual involved in a privileged communication can legally prevent the other party from disclosing the communication.

The best way to think about the difference between the two is to remember that confidentiality is an ethical duty you, as the lawyer, owe your client, and you can be disciplined for violating it. The attorney-client privilege, on the other hand, is governed by an evidentiary rule protecting your communications with your client from disclosure during litigation or another proceeding.

Confidentiality, Privilege or Both?

In the wrong hands, confidential information can be misused to commit illegal activity (e.g., fraud or discrimination), which can in turn result in costly lawsuits for the employer. Many states have laws protecting the confidentiality of certain information in the workplace. The disclosure of sensitive employee and management information can lead to a loss of employee trust, confidence and loyalty.

The Importance of Confidentiality in the Workplace

“Confidentiality” is a broad term that comprises a number of legal doctrines related to a lawyer’s duty not to reveal secrets. Among those doctrines are the attorney-client privilege, the work product doctrine, the spousal privilege, the psychiatrist-patient privilege, and the priest-penitent privilege.
