JCWI's claim was that the entire Scheme was in breach of Article 14 of the European Convention on Human Rights ("ECHR") read with Article 8 of the ECHR, and so unlawful, because it was causing landlords to discriminate against potential tenants who were not disqualified from renting under the Scheme (i.e. those with a perfect right to rent), on the grounds of their nationality and/or their race.
